

Public Notice of Availability: FAA Southern California Metroplex Draft Environmental Assessment Release

Summary: In accordance with the National Environmental Policy Act of 1969, 42 U.S.C. § 4321 et seq., and the Council on Environmental Quality (CEQ) regulations, 40 C.F.R. parts 1500-1508, the FAA issues this notice that it has prepared a Draft Environmental Assessment (EA) for the Southern California Metroplex (SoCal Metroplex) Project and has made it available for public review and comment. The Draft EA considers the potential environmental impacts of the implementation of the Project. The Project's Proposed Action would improve the efficiency of airspace in the Southern California Metroplex by optimizing aircraft arrival and departure routes at the EA Study Airports, including Burbank Bob Hope Airport, John Wayne Orange County Airport, Long Beach Airport, Los Angeles International Airport, Ontario International Airport, San Diego International Airport and 15 satellite airports throughout Southern California. A complete list of Study Airports is provided in the Draft EA.

The Project involves changes to aircraft flight routes and altitudes in certain areas. The Proposed Action does not increase the number of aircraft operations within the Metroplex, nor result in ground disturbance. Potential environmental impacts discussed in the EA were analyzed in accordance with FAA Order 1050.1E, *Environmental Impacts: Policies and Procedures*.

The General Study Area includes 21 Study Airports in Orange, Los Angeles, San Diego, Imperial, Riverside, San Bernardino, Santa Barbara, and Ventura Counties. The boundary extends approximately 35-40 miles north of Santa Barbara, 40-48 miles east of Palm Springs, and 10 miles south of San Diego. The western boundary of the General Study Area runs along the coastline.
